## Message from President Armor

I'd just like to tell the members about events/topics pertaining to the members of the NACS

- Please remember to submit your abstracts for the national, biennial meeting in Cancun, Mexico in June of 2003; abstract deadline (see web site) is 3 November 2002.
- Our web site continues to attract a large number of hits, now running over 1000 inquires to the site/month with climbing interest in the site as it becomes more popular
- I am pleased to report that we have added another local club to the NACS- welcome to the Southeastern Catalysis Society- see item in this Newsletter
- I received a strong set of nominations for both the Houdry and Emmett Awards and the nominations are now in the hands of the two juries who must make the selection. Results will be posted on the web site near the end of October and reported in the next Newsletter
- The NACS is incorporated within the State of Pennsylvania. Occasionally, we have made changes to our Bylaws to keep pace with changes in the way in which the Society operates and suggestions made by our legal counsel. At the last board meeting in March 2002, the Board adopted some minor revisions to the bylaws, which now must be voted on by the membership. This will be done at the Cancun meeting. In the Spring of 2003, I will post the proposed revisions to the bylaws on our web site and copies will be available to the membership prior to voting in Cancun. Many of the changes are cosmetic reflecting changes in the names of organizations we work with. Other minor changes include descriptions about the way the NACS operates the biennial meetings, the composition of the trustees of the Keith Hall Educational Fund, the nomination of officers for the national society, a process for replacing a vacancy created in the office of the president, a description of the Executive Committee, a procedure for passing resolutions of the Board on urgent matters, voting of the Board members, further specifics around the awards of the Society, and matters pertaining to the rules of our incorporation.
- The web site contains a folder on the History of Catalysis. This is a popular folder for which I get a lot of requests from those outside the field of catalysis seeking to learn about the subject. I've had some contributions, which are posted in this folder, but I certainly would like to get more items. ### Nominations Sought for The Robert Burwell Lectureship In Catalysis

The Robert Burwell Lectureship in Catalysis is sponsored and administered By The North American Catalysis Society. It is to be awarded biennially in odd-numbered years. The award consists of a plaque and an honorarium of \$5,000. An additional \$4,500 is available to cover traveling expenses. The award is given in recognition of substantial contributions to one or more areas in the field of catalysis with emphasis on discovery and understanding of catalytic phenomena, catalytic reaction mechanisms and identification and description of catalytic sites and species. The Awardee will be selected on the basis of his/her contributions to the catalytic literature and the current timeliness of these research contributions. The recipient may be invited to (1) visit and lecture to each of the affiliated Clubs/Societies with which mutually satisfactory arrangements can be made and (2) prepare a review paper(s) for publication covering these lectures. Publication will be in an appropriate periodical. Selection of the Awardee will be made by without regard to age, sex, nationality or affiliation. Selection of the Award winner will be made by a committee of renowned scientists and engineers appointed by the President of The North American Catalysis Society. Selection shall be made without regard for age, sex, nationality or affiliation. Posthumous awards will be made only when knowledge of the awardee's death is received after announcement of the Award Committee's decision. Nomination packages for the Award must be received before 15 December 2002 and should contain the nominee's qualifications, accomplishments, a nominating letter, a seconding letter and a biography of the nominee. A critical evaluation of the significance of candidate's qualifications should be made as well as a statement of the particular contribution(s) on which the nomination is based. Nomination documents should be submitted in six copies to the President of the Society along with no more than two seconding letters. #### The 18th North American Catalysis Society Meeting

The 18th North American Catalysis Society Meeting will be held at the Fiesta Americana Grand Coral Beach Hotel in Cancún, México, on June 1-6, 2003. Submission of papers dealing with original research in the following, non-limiting, list of topics is encouraged: Environmental catalysis and green chemistry; Hydrotreating and heavy crude upgrading; Catalysis by nanoparticles and nanostructures; Metal and oxides; Acid-base catalysis; Homogeneous catalysis and single site polymerization; Fuel Cells; Catalysis in organic synthesis; Combinatorial catalysis; Catalysts deactivation and reaction engineering; Computational catalysis; Biocatalysis; Advances in catalyst preparation and characterization; Industrial catalysis. The scientific program will consist of plenary Emmett and Houdry award lectures, keynote presentations, and oral and poster contributions. Among the confirmed keynote speakers are: D. #### Manzer, Grubbs Win ACS Awards

The American Chemical Society recognized Leo Manzer of DuPont with the 2003 E.V. Murphree Award in Industrial and Engineering Chemistry and Robert Grubbs of Caltech with the 2003 ACS Award in Homogeneous and Heterogeneous Catalysis. The Awards will be presented in March 2003 at the 225th ACS National Meeting in New Orleans, Louisiana. The Murphree Award recognizes individuals who have accomplished outstanding research of a theoretical or experimental nature in the fields of industrial chemistry or chemical engineering. The Award in Homogeneous and Heterogeneous Catalysis recognizes outstanding theoretical, experimental, or developmental research resulting in the advancement of understanding or application of homogeneous or heterogeneous catalysis. Manzer's involvement with various teams over the years has resulted in the commercialization of numerous catalytic processes which yielded hundreds of millions of dollars of revenue to DuPont. Some examples include the commercialization of a family of HFC's and HCFC's to replace the ozone depleting chlorofluorocarbons, a new catalyst for the production of phosgene that reduced byproduct emissions by 95% and novel Fischer-Tropsch catalysts which are in the process of being piloted by Conoco. Robert Grubbs is involved in the design, synthesis, and mechanistic studies of complexes that catalyze useful organic transformations. The major focus of the group over the past few years has been on the olefin metathesis reaction. This reaction has been used to prepare families of new polymeric structures from the ring opening polymerization (ROMP) of cyclic olefins which have useful mechanical, electronic or optical properties.

#### Call for 2003 Parravano Award Nominations

Nominations are invited for the 2003 Michigan Catalysis Society Parravano Award for Excellence in Catalysis Research and Development. The Award will be presented at the Twenty Fifth Annual Spring Symposium of the Michigan Catalysis Society, in May of 2003. The award winner will be invited to present an award address at the meeting. The award is given biennially to an individual from North America to recognize outstanding contributions to catalytic science and technology. The recipient of the award will be selected by a committee that is appointed by the officers of the Michigan Catalysis Society. The award consists of a medal and prize of \$500. The award is sponsored by the Memorial Trust Fund for Professor Giuseppe Parravano and is administered by the Michigan Catalysis Society.
